# Marine Conservancy & Hydrographic Policy

1. General Powers of Harbour Conservancy

Argyll and Bute Council as Harbour Authority has a duty to conserve the harbours for which it has responsibility, thus ensuring they remain fit for purpose to enable the various stakeholders and Argyll and Bute Council clients to use the ports successfully and safely.

This includes the provision of informa on regarding depths of water in the harbour and approaches, local no ces to mariners etc. The Harbour Authority also has the powers as the Local Lighthouse Authori es (LLA), as providers of aids to naviga on (AtoN).

## 3. Tidal Heights and Meteorological Condi ons

Argyll and Bute Council have installed equipment within its harbours to enable observa ons of the rise and fall of the de to be made.

Within their statutory harbours, dal height observa ons and readings are subject to regular visual check against a local de sta board to ensure correct opera on and repair and maintenance is contracted to a competent provider.

In addi on to dal informa on, Argyll and Bute Council also monitor and record data on prevailing condi ons such as wind strength and direc on and barometric pressure.

#### 4. Dredging

The Harbour Authority have the mandate (subject to consent from the landowner and Marine Scotland) to undertake dredging opera ons for maintenance or channel

- Maintain an AtoN database.
- Maintain an AtoN defect reporting system.
- Ensure procedures are also in place for emergency repair, reporting of navigational aid defects and appropriate issue of a navigational warning.

# 7. Review of Aids to Naviga on

Risk assessment and on-going consulta ons have determined the requirement for Aids to Naviga on in Argyll and Bute Council harbour areas. A program of full review with a periodicity not exceeding 5-years has been developed locally, this should where possible align with the general risk assessment for the harbour itself.

## 8 AtoN Failures, Maintenance and Inspec on

More significant wrecks or naviga onal hazards will be the responsibility of the Harbour Master to mark that, in their judgement, are or are likely to become a hazard to naviga on. They will be lit and buoyed un I raised, removed or destroyed.

Due regard will be made to the duty to protect the environment in the exercise of this and all other du es and powers. A risk assessment will be undertaken of any wreck in, or near the approaches to the harbour with the aim of reducing the risk of danger to naviga on to as low as reasonably prac cable.

In the event of a vessel becoming a wreck in or near the approaches to harbour limits, the process of removing the wreck is laid down in Sec on 252 of the Merchant Shipping Act 1995.

In event of a wreck on the approaches to the harbour, the Harbour Authority may:

- Take possession of, raise, remove or destroy the whole, or any part of the vessel, and any other property to which the power extends.
- Light or buoy the vessel un litis raised, removed or destroyed.
- Subject to various restric ons, sell the vessel or part of the vessel so raised or removed and any other property recovered during the exercise of the above powers.
